

# Achievements 2014

Membership organisations, especially those that aren't public-facing such as BUFDG, do much work 'behind the scenes', and as such it can often go unnoticed.

This summary of the group's activities during 2014 is to help raise awareness, and fill that gap.

#### **Sector Recruitment**

First up is recruitment. BUFDG helps its member organisations recruit staff. In 2014 we shared 1,225 sector job vacancies on our jobs page, sourced from jobs.ac.uk and your own websites, and provided HEIs with consultancy on the recruitment of 30 executive posts.


# **Membership Services**


In addition, we ran or facilitated 7 sector-wide surveys, covering areas such as Audit, Procurement, Fraud, and Student Accommodation





#### **Resources: documents and discussions**

The BUFDG documents area contains over 1,400 document resources. 370 new ones were added to the site this year The website includes a discussion board for members to network and ask questions on key issues. In 2014 there were 2,272 forum posts in 11 different topic areas.





#### Websites

The BUFDG websites are a key tool for serving members. The BUFDG and HEPA websites had over 550,000 page views during 2014, up from 416,000 in 2013 – an increase of 25%.

In addition, the organisation launched three new websites, for the new SORP, for the umbrella PHES Ltd company, and for HESPA. It also implemented a new email system and an internal intranet to improve productivity.
